Title of Bill: Rental Tax - Manufactured Home Parks

Synopsis: A Bill to increase the monthly rental tax on mobile homes in manufactured home parks from \$20 to \$22; providing an exemption for certain qualified mobile home owners; and to provide for the County Council to establish the monthly rental tax by resolution on an annual basis.

WHEREAS, pursuant to Section 402 of the Cecil County Charter (the "Charter"), the County

Executive (the "Executive") shall see that the affairs of the executive branch are administered properly and efficiently, and that employees of the executive branch faithfully perform their duties; and

WHEREAS, pursuant to Section 402 of the Charter, the duties and responsibilities of the Executive include, but are not limited to: (a) Supervising and directing offices, agencies and divisions of the executive branch and ensuring that County employees as well as County boards and commissions faithfully perform their duties; and, (b) preparing and submitting to the Council the annual County Budget; and

WHEREAS, pursuant to Part II, Chapter 244 (Manufactured Home Parks), § 244-6 (Rental tax; discount; exemption), subsection (A) of the Cecil County Code, every owner licensed to operate and conduct a manufactured home park in the County, under existing laws or regulations pertaining thereto, shall collect from any person, including the park owner if he/she owns a mobile home which occupies space in the park, paying charges for the rental, lease or use of any space, facility or accommodation in such park or for the providing of any services by such park owner, a tax thereon of \$20 per month; and

WHEREAS, the County Executive has submitted this Bill to increase the monthly rental tax on manufactured home parks from \$20.00 to \$22.00.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that Part II, Chapter 244 (Manufactured Home Parks), § 244-6 (Rental tax discount; exemption), subsection (A) of the Cecil County Code is amended as follows:

§ 244-6 (Rental Tax; discount; exemption)

(A) Pursuant to the authorization of [Article 24, Title 9, Subtitle 4, § 9-401, of the Annotated Code of Maryland] MD. CODE. ANN., LOCAL GOVERNMENT ARTICLE, § 20-501, as amended from time to time, every owner licensed to operate and conduct a manufactured home park in the County, under existing laws or regulations pertaining thereto, shall collect from any person, including the park owner if he/she owns a mobile home which occupies space in the park, paying charges for the rental, lease or use of any space, facility or accommodation in such park or for the providing of any services by such park owner, a tax thereon [of \$20 per month] OF TWENTY TWO DOLLARS (\$22.00) PER MONTH FOR FISCAL YEAR 2016. THE RENTAL TAX MAY, BEGINNING IN FISCAL YEAR 2017, BE ESTABLISHED BY RESOLUTION OF THE COUNCIL.

(D) Persons who are 65 years of age or older and/or persons who are mentally or physically handicapped who own manufactured homes in manufactured home parks are, IN FISCAL YEAR 2016, entitled to a tax exemption in the amount of [\$36] THIRTY NINE DOLLARS AND SIXTY CENTS (\$39.60) per year, which will be in the form of a refund paid by Cecil County, Maryland, upon approval of the application made by the manufactured home owner to the County or its designee. THE TAX EXEMPTION ESTABLISHED IN THIS SUBSECTION MAY, BEGINNING IN FISCAL YEAR 2017, BE ESTABLISHED BY RESOLUTION OF THE COUNCIL. Such refund is to be made in June of the fiscal year for which taxes were paid upon the presentation of receipts and approval of the application.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the rental tax be increased to \$22.00.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the \$22.00 rental tax shall be effective July 1, 2015 and shall continue in effect until changed by the County Council.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that persons who are 65 years of age or older and/or persons who are mentally or physically handicapped who own manufactured homes in manufactured home parks are, in Fiscal Year 2016, entitled to a tax exemption in the amount of Thirty Nine Dollars and Sixty Cents (\$39.60) per year, which will be in the form of a refund paid by Cecil County, Maryland, upon approval of the application made by the manufactured home owner to the County or its designee.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the tax exemption established in this Bill may, beginning in Fiscal Year 2017, be established by Resolution of the Council.
