WHEREAS, Chapter 202 (Fees), Article I (Deed Transfer Fee), § 202-1 (Transfer of Interest In Land Fee), of the Cecil County Code provides that there shall be paid to Cecil County, Maryland, before recording any deed or other instrument involving the transfer of an interest in land, a transfer fee in the amount of \$10.00; and,

WHEREAS, the County finds it necessary and proper to increase the transfer of interest in land fee pursuant to Chapter 202 (Fees), Article I (Deed Transfer Fee), by amending § 202-1 (Transfer of Interest In Land Fee), of the Cecil County Code. '

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that Chapter 202 (Fees), Article I (Deed Transfer Fee), § 202-1 (Transfer of Interest In Land Fee), of the Cecil County Code is amended as follows:

§ 202-1 (Transfer of Interest In Land Fee)

There shall be paid to Cecil County, Maryland, before recording any deed or other instrument involving the transfer of an interest in land, a transfer fee in the amount o[\$10] 0.5% OF THE CONSIDERATION INDENTIFIED IN THE DEED OR OTHER INSTRUMENT RECORDED WITH THE CLERK OF COURT FOR CECIL COUNTY. A TRANSFER FEE IMPOSED UNDER THIS SECTION DOES NOT APPLY TO AN INSTRUMENT OF WRITING EXEMPT FROM THE STATE TRANSFER TAX UNDER MD. CODE ANN., TAX – PROPERTY, §13-207, AND THE TRANSFER FEE FOR FIRST TIME HOME BUYERS UNDER MD. CODE ANN., TAX – PROPERTY, § 13-203 SHALL BE 0.25% OF THE CONSIDERATION PAYABLE FOR THE INSTRUMENT OF WRITING WITH THE TRANSFER FEE TO BE PAID ENTIRELY BY THE SELLER.

PROPERTIES UNDER CONTRACT AS OF JUNE 1, 2015, SHALL BE SUBJECT TO THE EXISTING TRANSFER FEE OF TEN DOLLARS (\$10.00), PROVIDED THAT SETTLEMENT ON THE TRANSFER OF LAND OCCURS ON OR BEFORE AUGUST 31, 2015; ELIGIBLE PROPERTIES THAT FAIL TO RECORD THE TRANSFER ON OR BEFORE SEPTEMBER 15, 2015, AT THE CECIL COUNTY DEPARTMENT OF FINANCE SHALL BE ASSESSED THE NEW 0.5% TRANSFER FEE UNLESS OTHERWISE EXEMPT.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the transfer of interest in land fee shall be effective July 1, 2015 and shall continue in effect until changed by the County Council.
