Supplemental Appropriation - Casino Local Impact Fund - Various Grants

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2015, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2016; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2016; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2015, the
6 County Council adopted the budget for Fiscal Year 2016; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2016 Casino Local Impact Fund revenue
8 estimate for Cecil County to carry forward from fund balance within the Casino Local Impact Fund the
9 following amounts:

- 10 a) To carry forward \$7,000 in VLT grant funds awarded to Cecil College and,
- 11 b) To carry forward \$2,600 in VLT grant funds awarded to Cecil County Memorial Post 6027 and,
- 12 c) To carry forward \$5,620 in VLT grant funds awarded to Cecil County Public Schools - Holly Hall
13 Elementary School and,
- 14 d) To carry forward \$6,210 in VLT grants funds awarded to Northern Chesapeake Hospice and,
- 15 e) To carry forward \$4,916 in VLT grant funds awarded to Open Door, Inc. and,
- 16 f) To carry forward \$25,000 in VLT grant funds awarded to the Town of North East and;

17 **WHEREAS**, such appropriation is necessary to provide \$51,346 of grant funding for the Casino Local
18 Impact Fund for grant related expenses within the VLT Local Community Grant Funds due to them being
19 unspent during the original grant period.

20 **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for
21 Cecil County, Maryland for Fiscal Year 2016 is hereby amended for the supplemental appropriation and by
22 amending the Current Expense Budget to appropriate carry forward of expenditure authority in the Casino
23 Local Impact Fund by the amount of \$51,346.

24 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by
25 the County Council of Cecil County, Maryland.
