1	WHEREAS , the Charter of Cecil County, Maryland, provides for the Legislative Branch of government as the			
2	County Council of Cecil County; and			
3	WHEREAS, the legislative powers and procedures are outlined in the Charter of Cecil County; and			
4	WHEREAS, the Charter allows the County Council to adopt and public additional rules of legislative procedure			
5	that may be desirable and not in conflict with this Charter; and			
6	WHEREAS, the County Council has determined that additional policies and procedures are necessary to			
7	support the legislative process in order to operate in a consistent and efficient manner; and			
8	WHEREAS, the Policies and Procedures of the Cecil County council may be amended by the County Council			
9	according to the legislative procedures in Sections 303-304 of the Charter of Cecil County, Maryland.			
10	NOW, THEREFORE, BE IT HEREBY RESOLVED by the County Council of Cecil County, Maryland that the			
11	proposed changes to the Policy and Procedures of the Cecil County Council is hereby approved as follows:			
12	Chapter 2: Meetings Generally			
13	Section 2-6. Cancellation and adjournment of meetings			
14	a) Scheduled meetings of the Council may be cancelled by the Council President or the Council. {The Council			
15	President may cancel a scheduled meeting due to inclement weather.} The Council may cancel a scheduled meeting			
16	by an affirmative vote of at least four (4) members, provided that the vote is taken at least seven (7) calendar days			
17				
18	scheduled for that meeting shall be rescheduled.			
19	b) If business cannot be concluded at the meeting in which it is scheduled for discussion, the Council may adjourn			
20	the proceedings to a later date, except business not concluded on a Legislative Day must be rescheduled on another			
21	Legislative Day, as per Chapter 2-1(a)			
22	c) WHEN CECIL COUNTY PUBLIC SCHOOLS ARE CLOSED FOR THE DAY BECAUSE OF INCLEMENT WEATHER, ALL			
23	SCHEDULED MEETINGS OF THE COUNCIL WILL BE CANCELLED. WHEN THE PUBLIC SCHOOLS OPEN LATE DUE TO			
24	INCLEMENT WEATHER, THE MORNING COUNCIL WORK SESSION IS CANCELLED. WHEN THE PUBLIC SCHOOLS CLOSE			
25	EARLY DUE TO INCLEMENT WEATHER, THE EVENING LEGISLATIVE SESSION IS CANCELLED.			
26	BE IT FURTHER RESOLVED by the County Council of Cecil County that all provisions of this Resolution shall			

take effect on the date the Resolution is adopted by the Council.
