	WHEREAS, Section 6-302 of the Tax-property Article, Annotated Code of Maryland requires
th	e governing body of each county to annually set the tax rate for the next taxable year; and

**WHEREAS**, Section 508 of the Charter of Cecil County requires that County Council shall levy the amount of taxes required by the Budget to ensure that the Budget is balanced so that proposed revenues equal proposed expenditures;

WHEREAS, pursuant to Section 110-22 of the Code of Cecil County, the County shall levy annually upon the property in the Winding Brook Special Taxing District a sum sufficient to pay the costs of trash collection, mowing of common areas, and general maintenance of the district; and,

WHEREAS, pursuant to Section 110-22 of the Code of Cecil County, the annual levy upon the property in the Winding Brook Special Taxing District shall be collected as all other taxes in the County are collected and shall be paid over to the Director of Finance

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN LEGISLATIVE SESSION, as follows:

- That a County property tax for the taxable year beginning July 1, 2014 and ending June 30, 2015, is hereby levied and imposed on all assessments, persons or property subject to ordinary taxation in Cecil County; and
- 2. That the rate of County taxation for such taxable year for real property is hereby fixed at Ninety-nine and Seven Hundredths Cents (\$.9907) on each \$100 of assessed valuation of such property;
  - 3. That the rate of County taxation for such taxable year for personal property, as well as for operating real property (as described in Section 8-109(c) of the Tax Property Article, Annotated Code of Maryland, is hereby fixed at \$2.4768 on each \$100 of assessed valuation of such property; and
- 4. That the Winding Brook Special Taxing District property tax for the taxable year beginning July 1, 2014 and ending June 30, 2015, is hereby levied and imposed on all parcels in the Special Taxing District at the rate of \$225.59 per parcel.
- AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, IN
  LEGISLATIVE SESSION That the County Executive and Director of Finance will cause the property tax to be
  collected in the manner provided by law.
